



RESOLUTION NO. 46

WHEREAS, the Redistricting Committee designated by the Dunn County Board of Supervisors has carried out its charge and has developed a tentative supervisory district plan in accordance with the laws of the State of Wisconsin.

NOW, THEREFORE, BE IT RESOLVED, that the following tentative supervisory district plan be adopted by the Dunn County Board of Supervisors:

- District 1: Townships of Sand Creek and Wilson; Village of Ridgeland; population = 1351
- District 2: Townships of New Haven and Sheridan; that part of the Township of Tiffany west of the South Fork Hay River, north of County Road N or west of County Road Q; population = 1391
- District 3: Village of Boyceville; that part of the Township of Tiffany east of County Road Q or south of County Road N; that part of the Township of Hay River south of County Road N and west of County Road F; population = 1356
- District 4: Township of Otter Creek; Village of Wheeler; that part of the Township of Tiffany east of the South Fork Hay River; that part of the Township of Hay River north of County Road N or east of County Road F; population = 1405
- District 5: Township of Grant; part of the Township of Colfax north and west of the Red Cedar River, and that part of the Township of Colfax east of the Red Cedar River and west of County Road M and north of the Village of Colfax; part of the Township of Tainter including all that area north of a line beginning on 850th Avenue, follow 850th Avenue east to County Road D, south on County Road D to Red Cedar River and Lake Tainter; follow the north shore of the Red Cedar River and lower Lake Tainter to the town line; population = 1410
- District 6: That part of the Township of Tainter south of the north shore of lower Tainter Lake and the Red Cedar River, and east of County Road G or County Road BB; that part of the Township of Colfax south of the Red Cedar River on the west, and south of County Road N on the east; that part of the Township of Elk Mound north of of a line connecting County Road E to 690th Avenue to 910th Street to County Road M to 740th Street north to the town line; population = 1400
- District 7: The Village of Colfax; that part of the Township of Colfax east of County Road M and north of County Road N; population = 1359
- District 8: Township of Sherman; part of the Township of Tainter south of 850th, and west of County Road G or County Road BB; population = 1364
- District 9: Villages of Downing and Knapp; Township of Stanton; population = 1393
- District 10: Township of Lucas; that part of the Township of Weston including all that area north of a line beginning at 370th Avenue east to 350th Avenue, thence east on 350th Avenue to 210th Street, thence north on 210th Street to County Road X, thence east on County Road X to 340th Avenue, thence east on 340th Avenue to County Road K, thence south on County Road K to State Highway 72, thence east on State Highway 72 to the town line; part of the township of Menomonie south and west of a line connecting 470th Avenue east to County Road K, south to 440th Avenue, east to 430th Avenue, east to County Road D, east to the Red Cedar River and south to the town line; that part of the Township of Dunn north of State Highway 72 and west of the Red Cedar River and State Highway 25; population = 1350
- District 11: Part of the Township of Menomonie: beginning at the intersection of County Road Y and the southern city limits, commence along the city limits in a westerly direction to 440th Street; thence south on 440th Street to County Road D; thence southwesterly on County Road D to the Red Cedar River; follow the Red Cedar River to the town line; thence east along the town line to State Highway 25; thence north on State Highway 25 to 430th Avenue; thence east on 430th Avenue to 490th Street; thence south on 490th Street to 410th Avenue; thence east on 410th Avenue to County Road Y; thence north on County Road Y to the point of beginning; population = 1352

- District 12: That part of the Township of Menomonie north of a line connecting 470th Avenue to County Road K to 440th Avenue to County Road D to 440th Street north to the southern city limits; population = 1406
- District 13: Beginning at the intersection of the east bank of the Red Cedar River and the northern city limits, commence west along the city limits to Wilson Street; thence south on Wilson Street to Interstate 94; thence west on Interstate 94 to the Union Pacific Railroad; thence south on the Union Pacific Railroad to Maple Avenue; thence west on Maple Avenue to Tainter Street; thence south on Tainter Street to Broadway Street; thence south on Broadway Street to the Broadway bridge over Lake Menomin, and including all of Lake Menomin; population = 1359
- District 14: Beginning at the intersection of the northern city limits and Wilson Street, follow the city limits to the west and south to the intersection with State Highway 29, thence in a southeasterly direction on State Highway 29 to the west bank of the Red Cedar River, thence north along the west bank of the Red Cedar River to Meadow Hill Drive; thence north on Meadow Hill Drive to Broadway Street; thence north on Broadway Street to Tainter Street; thence north on Tainter Street to Maple Avenue; thence east on Maple Avenue to the Union Pacific Railroad; thence north along the Union Pacific Railroad to Interstate 94; thence east on Interstate 94 to Wilson Street; thence north on Wilson Street to the point of beginning; population = 1360
- District 15: Beginning at the intersection of Meadow Hill Drive and Broadway Street, commence west on Meadow Hill Drive to the Red Cedar River; follow the west bank of the Red Cedar River to State Highway 29; thence west on State Highway 29 to the city limits; thence follow the city limits south and east to the Red Cedar River and including the Red Cedar River from Lake Menomin to the south city limits; thence follow the Red Cedar River to Galloway Creek; thence southeasterly on Galloway Creek to 5th Street West; thence north on 5th Street West to 12th Avenue; thence west on 12th Avenue to Riverview Drive; thence north on Riverview Drive to River Road; thence north on River Road to Wilson Avenue; thence east on Wilson Avenue to 2nd Street West; thence north on 2nd Street West to Main Street; thence east on Main Street to 6th Street East; thence north on 6th Street East 1 block to the south shore of Lake Menomin; thence follow Lake Menomin to the intersection with Broadway Street; thence north on Broadway Street to the point of beginning; population = 1364
- District 16: Beginning at the intersection of 11th Street and 5th Avenue, commence west on 5th Avenue to Crescent Street; thence southwest on Crescent to the intersection of Main Street and 6th Street East; thence west on Main Street to 4th Street East; thence south on 4th Street East to 9th Avenue; thence west on 9th Avenue to 3rd Street East; thence south on 3rd Street East to 13th Avenue; thence east on 13th Avenue to 5th Street East; thence south on 5th Street East to 16th Avenue; thence east on 16th Avenue to 9th Street East; thence north on 9th Street East to 14th Avenue; thence east on 14th Avenue to 11th Street East; thence north on 11th Street East to the point of beginning; Population = 1400
- District 17: Beginning at the intersection of Main Street and 4th Street East, commence west on Main Street to 2nd Street West; thence south on 2nd Street West to Wilson Avenue; thence west on Wilson Avenue to River Road; thence south on River Road to Riverview Drive; thence south on Riverview Drive to 12th Avenue; thence east on 12th Avenue to 5th Street West; thence south on 5th Street West to 14th Avenue; thence east on 14th Avenue to 4th Street West; thence south on 4th Street West to 16th Avenue; thence east on 16th Avenue to Broadway Street; thence north on Broadway Street to 10th Avenue; thence east on 10th Avenue to 3rd Street East; thence north on 3rd Street East to 9th Avenue; thence east on 9th Avenue to 4th Street East; thence north on 4th Street East to the point of beginning; population = 1345
- District 18: Beginning at the intersection of the Red Cedar River and Galloway Creek, commence south along the east bank of the Red Cedar River to the intersection with the western city limits; thence follow the city limits around to the east to Harvey Drive; thence north on Harvey Drive to Terrill Road; thence west on Terrill Road to Bongey Drive; thence north on Bongey Drive to 19th Avenue; thence east on 19th Avenue to 3rd Street West; thence south on 3rd Street West to 20th Avenue; thence east on 20th Avenue to Broadway Street; thence north on Broadway to Galloway Creek; follow Galloway Creek in a northwesterly direction to the point of beginning; population = 1360

- District 19: Beginning at the intersection of 10th Avenue and 3rd Street East, commence west on 10th Avenue to Broadway Street; thence south on Broadway Street to 16th Avenue; thence west on 16th Avenue to 4th Street West; thence north on 4th Street west to 14th Avenue; thence west on 14th Avenue to 5th Street West; thence south on 5th Street West to Galloway Creek; thence follow Galloway Creek in a southeasterly direction to Broadway Street; thence south on Broadway Street to 20th Avenue; thence east on 20th Avenue to 5th Street East; thence north on 5th Street East to 13th Avenue; thence west on 13th Avenue to 3rd Street East; thence north on 3rd Street East to the point of beginning; population = 1364
- District 20: Beginning at the intersection of 20th Avenue and 4th Street East, commence west along 20th Avenue to 3rd Street West; thence north on 3rd Street West to 19th Avenue; thence west on 19th Avenue to Bongey Drive; thence south on Bongey Drive to Terrill Road; thence east on Terrill Road to Harvey Drive; thence south on Harvey Drive to the southern city limits; follow the city limits in an easterly direction to 9th Street; thence north on 9th Street to 24th Avenue; thence west on 24th Avenue to 4th Street East; thence north on 4th Street East to the point of beginning; population = 1332
- District 21: Beginning at the intersection of County Road J and the city limits, commence west on County Road J to 9th Street East; thence south on 9th Street East to 16th Avenue; thence west on 16th Avenue to 5th Street East; thence south on 5th Street East to 20th Avenue; thence west on 20th Avenue to 4th Street East; thence south on 4th Street East to 24th Avenue; thence east on 24th Avenue to 9th Street East; thence south on 9th Street East to the city limits; thence follow the city limits east and north to the point of beginning; population = 1333
- District 22: Beginning at the intersection of the city limits and State Highway 12 East, commence west along State Highway 12 to Red Cedar Street; thence north on Red Cedar Street to the Service Road; thence west on the Service Road to 19th Avenue; thence north on 19th Avenue to 2nd Avenue North; thence west on 2nd Avenue North to 13th Street; thence north on 13th Street to Shorewood Drive; thence north on Shorewood Drive to the intersection with Lake Menomin; thence follow the shoreline of Lake Menomin southwesterly to 6th Street East; at the intersection of 6th Street East and Crescent Street, commence east along Crescent to 5th Avenue South; thence east on 5th Avenue South to 11th Street East; thence south on 11th Street East to County Road J; thence in a southeasterly direction along County Road J to the city limits; thence north along the city limits to the point of beginning; Population = 1366
- District 23: Beginning at the intersection of State Highway 12 East and the city limits, commence around the city limits east, thence north, thence west to the intersection with the Red Cedar River; thence south along the Red Cedar River to Lake Menomin; thence follow the east shore of Lake Menomin to the Evergreen Isle Cemetery Bridge and including the Evergreen Isle Cemetery, thence south on Shorewood Drive to 13th Street; thence south on 13th Street to 2nd Avenue North; thence east on 2nd Avenue North to 19th Street; thence south on 19th Street to 1st Avenue North; thence east on 1st Avenue North to the Service Road; thence east along the Service Road to Red Cedar Street; thence south on Red Cedar Street to State Highway 12; thence east on State Highway 12 to the point of beginning; Population = 1354
- District 24: That part of the Township of Red Cedar north of a line connecting County Road J to 510th Avenue, to 610th Street, south on 610th Street to 490th Avenue, east on 490th Avenue to the town line; population = 1409

- District 25: Village of Elk Mound; that part of the Township of Elk Mound north of a line connecting State Highway 12 to 570th Avenue on the west side of the Village of Elk Mound; and 970th Street north to State Highway 29 on the east side of the Village of Elk Mound; and south of a line connecting County Road E to 690th Avenue to 910th Street north to County Road M to 740th Street north to the town line; population = 1378
- District 26: That part of the Township of Elk Mound south of a line connecting U.S. Highway 12 and 570th Avenue on the west side of the Village of Elk Mound; and 970th Street north to State Highway 29 on the east side of the Village of Elk Mound; that part of the Township of Red Cedar described as follows: beginning at the intersection of 610th Street and 510th Avenue, commence west on 510th Avenue to County Road J, thence south on County Road J to 430th Avenue, thence east on 430th Avenue to 610th Street, thence south on 610th Street to 420th Avenue, thence east on 420th Avenue to the town line, thence north along the town line to 490th Avenue, thence west on 490th Avenue to 610th Street, thence north on 610th Street to the point of beginning; that part of the Township Spring Brook located north of County Road J or north of County Road C; population = 1392
- District 27: Townships of Peru and Rock Creek; that part of the Township of Spring Brook south of County Road C; population = 1400
- District 28: That part of the Township of Dunn east of the Red Cedar River; that part of the Township of Menomonie described as follows: beginning at the intersection of the east town line and the southeastern corner of the city limits, thence commence west along the city limits to County Road Y; thence south on Y to 410th Avenue; thence west on 410th Avenue to 490th Street; thence north on 490th Street to 430th Avenue; thence west on 430th Avenue to State Highway 25; thence south on State Highway 25 to southern town line; thence east along the southern town line to the eastern town line; thence north along the east town line to the point of beginning; that part of the Town of Red Cedar south of a line connecting County Road J to 430th Avenue; thence east on 430th Avenue to 610th Street; thence south on 610th Street to 420th Avenue; thence east on 420th Avenue to the town line; that part of the township of Spring Brook south of County Road J, north and west of County Road C; population = 1409
- District 29: Township of Eau Galle; that part of the Township of Dunn south of State Highway 72 and west of the Red Cedar River; that part of the Township of Weston south of a line beginning at 370th Avenue, east to 350th Avenue to 210th Street, thence north on 210th Street to County Road X, thence east on County Road X to 340th Avenue, thence east on 340th Avenue to County Road K, thence south on County Road K to State Highway 72, thence east on State Highway 72 to the town line; population = 1396
